## **Subdivision Review Status Checklist**

### **Esbenshade Greenhouse Time Extension**

### **Custom Milling Warehouse**

### PUBLIC COMMENT

MANAGERS REPORT - Ms. Hollenbach reviewed the report with the Board.

**Park and Recreation**- A ball field light and pole were damaged during Hurricane Sandy and will need to be replaced.

A motion was made by David Franke, seconded by Claude Beaver, to authorize the replacement of the ball field light and pole at the Blandon Ball Field at a cost not to exceed \$6,417.20. Hearing no questions on the motion, all members voted, "Aye". Motion carried.

#### Truck #1 Tire replacement of four rear tires

A motion was made by David Franke, seconded by Claude Beaver, to purchase four tires at a cost not to exceed \$332.00 each. Hearing no questions on the motion, all members voted "Aye". Motion carried.

Ms. Hollenbach advised the Board that she has began writing her daily, monthly and annual job duties and beginning in January 2013, the Road Crew will have monthly goals to attain.

#### **RESOLUTIONS & ORDINANCES**

### 2013 Budget

Ms. Hollenbach advised the Board that the Township did not received the Police 2013 Budget until December 13, 2013. The Township returned the budget back to the police and requested that they reduce their budget by \$157,000. The Township also requested that a police officer be present at this evening's meeting. The Board was advised that there has been no tax increase for 12 years and the reserve has been depleted. The Board voiced their concerns that if the police cannot reduce their budget or if there is a severe winter, there is no room in the budget to accommodate for the additional expenditures. Ms. Hollenbach advised the Board that they may increase the 2013 budget by 10% without re-advertising.

The Tax Collector also requested an increase in her pay rate. The Board advised the Township Manager to look into possibilities. Mrs. Hassler had not seen an increase in at least sixteen years.

#### Resolution #33-2012 – Fixing the Tax Rate for the Year 2013

A motion was made by David Franke, seconded by Claude Beaver, to adopt Resolution #33-2012 – Fixing the Tax Rate for the Year 2013 with a tax rate to .0015 mills. Hearing no questions on the motion, all members voted, "Aye". Motion carried.

## **Resolution #34-2012 – 2013 Budget**

A motion was made by David Franke, seconded by Claude Beaver, to adopt Resolution #34-2013 - 2013 Budget with changes made to line 4 and line 16. Hearing no questions on the motion, all members voted, "Aye". Motion carried.
