PUBLIC COMMENT

Bill Weidemann, 239 Spirit Court, Blandon, PA commented on the reduced amount of speeding vehicles on Spirit Court. He credits and thanks the police for making an effort to monitor traffic and conducting patrols on Spirit Court during peak speeding times. He asked the Board to reconsider some of their decisions as they prepare to implement the recycling program in Maidencreek Township. He feels one company could accomplish trash collection and recycling. Allowing one company to perform both services would reduce the cost for Maidencreek property owners and at the same time reduce the amount of truck traffic on Township roadways.

Barbara Hassler, 16 Adele Ave., Blandon, PA (Tax Collector) asked the Board how they arrived at the \$55.00 recycling fee and had they contacted other municipalities to obtain information to implement our recycling program. She informed the Board that the \$55.00 recycling fee may not appear on the County Tax bills and she will not be responsible for collecting and/or maintaining records for the recycling fees.

The Township Solicitor agreed to investigate the issue of the recycling fee appearing on the County Tax bills. He stated that the Operations Director found that some municipalities include their recycling assessment on the County Tax bills. The Chairman added that the Board arrived at the \$55.00 recycling fee by dividing the amount of Maidencreek Township property owners into the estimated cost of the program.

The Solicitor confirmed that the developer's attorney will provide information pertaining to Lot 133 in Willow Gardens by the end of January 2003.
