

## RESOLUTION 2-2018

A RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF MAIDENCREEK, BERKS COUNTY, PENNSYLVANIA, APPOINTING THE SOLICITOR FOR THE MAIDENCREEK TOWNSHIP BOARD OF SUPERVISORS , PLANNING COMMISSION AND PARK AND RECREATION BOARD AND ESTABLISHING THE FEE SCHEDULE FROM JANUARY 2, 2018 THROUGH THE DATE OF THE REORGANIZATION MEETING TO BE HELD IN JANUARY OF 2019.

WHEREAS, it is the Board of Supervisors of Maiden creek Township desire to appoint a solicitor to serve at the pleasure of the Board Supervisors to perform services for the Board of Supervisors, the Planning Commission and the Park and Recreation Board of Maiden creek Township; and

WHEREAS, the Board of Supervisors of Maiden creek Township has the authority to appoint a person or firm to the position of Township Solicitor and determine their compensation in accordance with Article XI, section 1101 of the Second Class Township Code;

NOW, THEREFORE, in consideration of the above recitals, the Board of Supervisors of the Township of Maiden creek, Berks County, Pennsylvania, resolve as follows:

### **Section 1. Appointment of Township Solicitor**

The Board of Supervisors of Maiden creek Township hereby appoints the law firm of ORLANDO LAW OFFICES to the office of Township Solicitor to serve at the pleasure of the Board in accordance with Article XI of the Second Class Township Code.

### **Section 2. Fee Schedule**

The fees for the Township Solicitor for 2018 shall be:


Except as provided, all routine representation of the Township including attendance at meetings and court legal representation to be accomplished at the rate of \$175 per hour of attorney time (including senior attorneys) billed in minimum increments

of two-tenth of an hour. Expenses, costs, filing fees, service fees, notary fees, advertising and similar disbursements are in addition to the hourly rate quoted as well as paralegal charges where appropriate. Paralegal rate shall be billed at \$140 per hour on the same basis.


