

RESOLUTION 4-2014

RESOLUTION OF THE BOARD OF SUPERVISORS OF THE TOWNSHIP OF MAIDENCREEK, BERKS COUNTY, PENNSYLVANIA, APPOINTING AN ENGINEERING CONSULTANT FOR THE PARK AND RECREATION BOARD, AND ESTABLISHING THE FEE SCHEDULE FOR THE ENGINEERING CONSULTANT FROM JANUARY 6, 2014 THROUGH THE DATE OF THE REORGANIZATION MEETING TO BE HELD IN JANUARY OF 2015.

WHEREAS, it is the Board of Supervisors of Maiden Creek Township desire to appoint an engineering consultant to serve at the pleasure of the Board of Supervisors to perform services for the Park and Recreation Board of Maiden Creek Township; and

WHEREAS, the Board of Supervisors of Maiden Creek Township has the authority to appoint a person or firm to the position of Township Engineer and determine their compensation in accordance with Article XII, section 1201 of the Second Class Township Code.

NOW, THEREFORE, in consideration of the above recitals, the Board of Supervisors of the Township of Maiden Creek, Berks County, Pennsylvania, resolves as follows:

Section 1. Appointment of the Engineering Consultant for the Park and Recreation Board






