# Maidencreek Township Board of Supervisors Reorganization Meeting January 3, 2017

The meeting was called to order at 7:03 p.m.

A motion was made by Joseph Rudderow III to appoint Diane Hollenbach Chairperson Pro Tem and Recording Secretary Pro Tem for the purpose of electing officers for the Township of Maidencreek in 2017. David Franke seconded the motion and hearing no questions on the motion, it passed unanimously.

Diane Hollenbach took roll call to determine a quorum. David Franke and Joseph Rudderow III were present. Claude Beaver was absent.

A motion was made by Joseph Rudderow III to adopt Resolution 8-2017 to appoint the Joint Planning Commission with a term expiring 12/31/2017. David Franke seconded the motion and hearing no questions on the motion, it passed unanimously.

# CAPITAL AUTHORIZATIONS, RESOLUTION

A motion was made by David Franke to designate Tompkins/VIST Bank, Fleetwood Bank, First Priority Bank, BBT and PLIGIT as depositories for all Township funds and Tompkins/VIST Bank for the collected tax funds of the Maidencreek Township Tax Collector. Joseph Rudderow III seconded the motion and hearing no questions on the motion, it passed unanimously.

A motion was made by David Franke to authorize the County of Berks to print and mail joint real estate tax bills with the Township sharing equally in the cost for printing and postage. Joseph Rudderow III seconded the motion and hearing no questions on the motion, it passed unanimously.

A motion was made by David Franke to authorize any Supervisor to spend \$2500.00 for emergency situations and the Manager to spend \$750 at any time for daily operational needs during 2017. Joseph Rudderow III seconded the motion and hearing no questions on the motion, it passed unanimously.

A motion was made by David Franke to authorize the Township Manager to purchase Security Bonds for 2017 for the Secretary/Treasurer in the amount of \$800,000.00 and Real Estate Tax Collector in the amount of \$500,000.00. Joseph Rudderow III seconded the motion and hearing no questions on the motion, it passed unanimously.

A motion was made by David Franke to adopt Resolution 9-2017 authorizing the Board of Supervisors to appoint an independent auditor, Kosmerl and Company to audit the financial records of 2016. Joseph Rudderow III seconded the motion and hearing no questions on the motion, it passed unanimously.

A motion was made by David Franke to set the mileage rate at the IRS approved rate of .535 per mile. Joseph Rudderow III seconded the motion and hearing no questions on the motion, it passed unanimously.

#### RESOLUTION 10-2017

A motion was made by David Franke to adopt Resolution 10-2017 authorizing the Blandon Ambulance

Service to provide emergency medical service to Maidencreek Township. Joseph Rudderow III seconded the motion. David Franke asked what the procedure would be when the ambulance merger occurred. Diane Hollenbach stated that a new resolution would be adopted naming the new merged ambulance service and hearing no questions on the motion, it passed unanimously.

# RESOLUTION 11-2017

A motion was made by David Franke to adopt Resolution 11-2017 authorizing the Blandon Fire Company to provide fire protection and emergency medical service to Maidencreek Township. Joseph Rudderow III seconded the motion and hearing no questions on the motion, it passed unanimously.

# APPOINT FIRE POLICE PERSONNEL

A motion was made by Joseph Rudderow III to appoint personnel to the following positions: Fire Police Captain-Floyd Richards, Fire Police Lieutenant-Teresa Franke and James Schoellkopf Jr., Fire Police Personnel - Daniel Miller, Sr and Ed Byers. David Franke seconded the motion and hearing no questions on the motion, it passed unanimously.

Since there was no further business, a motion was made by David Franke, seconded by Joseph Rudderow III, to adjourn the January 3, 2017 Reorganization Meeting at 7:27 pm. Hearing no questions on the motion, all members voted, "Aye." Motion carried.
