CHAIRPERSON AND VICE CHAIRPERSON POSITIONS

A motion was made by Claude Beaver, seconded by David Franke, to nominate Joseph Rudderow III as Chairperson of the Maidencreek Township Board of Supervisors in 2015. A motion was made by David Franke, seconded by Claude Beaver, to authorize the Township Manger to purchase Security Bonds for 2015 for the Secretary/Treasurer in the amount of \$500,000.00 and Real Estate Tax Collector in the amount of \$500,000.00.
