

Motions – Park and Rec February 14, 2018 Meeting

RULES & REGULATIONS FOR HOCH ROAD DOG PARK

Becky Miller made a motion to accept the rules and regulations as presented and authorize the submittal to the Board of Supervisors and Solicitor for comments and approval, seconded by Jeremy Breidenstein. All present voted in favor; the motion passed.

PLAYGROUND MULCH

Jeremy Breidenstein made a motion to recommend to the Board of Supervisors to purchase 120 yards of playground mulch from General Recreation at a cost not to exceed \$2, 516.00, seconded by Becky Miller. All present voted in favor; the motion passed.

INFIELD MIX

Becky Miller made a motion to recommend to the Board of Supervisors to purchase 57 tons of infield mix from Martin Stone Quarries at a price not to exceed \$1,111.50, seconded by Jeremy Breidenstein. All present voted in favor; the motion passed.

Rules and Regulations

1. Hours of operation are dawn to dusk. Entry otherwise is considered trespassing. The parking lot will not be plowed and the park may be closed for snow.

2. A dog must be licensed, healthy, parasite-free, over the age of 16 weeks, and not in heat.

3. Children under age 5 are prohibited for safety reasons. Older children must be closely supervised. Nobody under 18 allowed without a responsible adult.

4. Use of this dog park is at your own risk. Owners are legally responsible for their dogs and any injury or damages caused by them.

5. A dog (or person) that has an aggressive episode must leave the park immediately. In case of injuries, call 911. Repeat offenders may be banned permanently from park.

6. Choke chains and pronged or spiked collars must be removed in the vestibule area.

7. Dogs must be on leash when entering and exiting the dog area.

8. Owners must carry a leash at all times, and be alert to their dogs' actions and demeanor.

9. Nobody wants stinky feet, so pick up after your dog. If you see someone else's droppings, assume it was accidentally missed, be a good citizen, and pick it up. Waste receptacles are located outside the main gate.

10. To prevent aggressive behavior, dog food, people food, and rawhide are prohibited. Training treats are OK.

11. To prevent injury, tug toys and squeaky toys are prohibited. Balls and disc toys are great!

12. Discourage your dog from digging or damaging park property. Firmly fill any holes made by your dog.

13. The small dog enclosure is only for dogs weighing less than 30 pounds. Though not recommended, small dogs may play in the large dog area, at the owner's discretion and risk.

14. Smoking, vaping, and drinking alcohol in the park is prohibited.

15. Take everything with you when you exit the park, including toys, and ensure that **the gate is securely closed.**
