

Customer agrees to save harmless and indemnify Reilly Sweeping, Inc., including reasonable attorney's fees and court costs, should Reilly Sweeping, Inc. in any way be responsible and/or held liable for said water charges used in conjunction herein.

*Acceptance of Proposal:* The above prices, specifications and conditions are satisfactory and are hereby accepted. You are authorized to do the work as specified. If payment is not received by the 30th day following completion of the invoiced work, RSI will commence litigation to collect any such delinquent payments. We agree to pay all reasonable attorneys' fees incurred by RSI in such collection efforts. The parties also agree to the jurisdiction of venue the Bucks County Court of Common Pleas for all litigation matters arising from this agreement.
