RESOLUTION NO. 10 - 2023**

A RESOLUTION DESIGNATING NORTHERN BERKS EMERGENCY
MEDICAL SERVICES AS THE PRIMARY PROVIDER OF EMERGENCY
MEDICAL AND AMBULANCE SERVICES FOR 2023.

WHEREAS it is the intention of the Board of Supervisors of Maiden creek Township to contribute to the public safety of the residents of Maiden creek Township in the area of emergency medical service and transport service for 2023;

WHEREAS the Board of Supervisors of Maiden creek Township has the authority to appoint a person or firm to the position of Township Solicitor and determine their compensation in accordance with Article XI, section 1101 of the Second Class Township Code;

NOW, THEREFORE be it resolved by the Board of Supervisors of the Township of Maiden creek, Berks County, Pennsylvania, and it is hereby resolved by the authority of the same as follows:

Section 1 - Designation of Primary Emergency Medical and Ambulance Services Provider

The Maiden creek Township Board of Supervisors hereby designates Northern Berks Emergency Medical Services whose principal office is located at 26 E. Wall Street, PO Box 625, Leesport, PA 19533.

Section 2 - Term of Office

The term of this designation shall be from this third day of January 2023 AD until the next Maiden creek Township Reorganization Meeting to be held the third day of January 2024 AD.

Section 3 - Delegation of Authority

Northern Berks Emergency Medical Services is designated as the primary provider of emergency medical and ambulance services necessary for the protection of the health and welfare of persons located within the Township of Maiden creek and are permitted to respond to out-of-jurisdiction calls to, but are not limited to, prevent of loss of life and response to medical emergencies.


