RESOLUTION NO. 21 – 2023

A RESOLUTION DESIGNATING THE TOWNSHIP MANAGER AS THE
OFFICIAL RESPONSIBLE FOR THE SIGNATURE OF AN AGREEMENT
AND AGREEMENT TO BE PARTY TO SUCH AGREEMENT WITH
THE COMMONWEALTH FINANCING AUTHORITY FOR A GRANT.

WHEREAS Maiden creek Township (“Applicant”) desires to undertake the project,
“**Maiden creek Township Comprehensive Recreation, Park & Open Space, and Greenways
Plan**” (“Maiden creek Township Comprehensive Plan”); and

WHEREAS the applicant desires to receive from the Commonwealth Financing Authority
("Authority") a Greenways, Trails, and Recreation Program grant of \$47,493.00 to carry out this
project; and

WHEREAS the application package includes Terms and Conditions, Agreements, and
other Documents of Grant and requires agreement between the Authority and the Township;
and

WHEREAS the applicant understands that the contents of these documents, including
appendices referred to therein, will become the terms and conditions of a Grant Agreement
between the applicant and the Authority if the applicant is awarded a grant; and

NOW, THEREFORE in consideration of the above recitals, the Board of Supervisors of the
Township of Maiden creek, Berks County, Pennsylvania, resolve as follows:

Section 1 - Designation of Official

The grant application may be electronically signed on behalf of the applicant by "Hunter
Larry Ahrens" who, at the time of signing, serves as Township Manager and maintains the email
address hlahrens@maidencreek.net.

Section 2 - Retroactivity

If this Official signed the Grant Application Electronic Authorization before the passage of
this Resolution, this grant of authority applies retroactively to the date of signing.

Section 3 - Execution of Agreement

If the applicant is awarded a grant, the Grant Application Electronic Authorization, signed by the above Official, will become the applicant/grantee's executed signature page for the Grant Agreement, and the applicant/grantee will be bound by the Grant Agreement.

Section 4 - Delegation of Authority

Any amendment to the Grant Agreement may be signed on behalf of the grantee by the Official who, at the time of signing of the amendment, has the title "Township Manager" specified in paragraph 1 and the grantee will be bound by the amendment.


