RESOLUTION NO. 26 – 2023**

A RESOLUTION DECLARING A DISASTER FOR THE ENTIRETY OF
MAIDENCREEK TOWNSHIP

WHEREAS the Board of Supervisors of Maiden creek Township has the authority to declare disaster or state of emergency within its jurisdiction where the Township is responsible for the proper maintenance of public streets and public safety;

WHEREAS on July 9, 2023, the entirety of Maiden creek Township experienced flooding, large amounts of water runoff;

WHEREAS the Board of Supervisors is concerned about the degree of damage and the jeopardy to public safety that damage poses;

NOW, THEREFORE in consideration of the above recitals, the Board of Supervisors of the Township of Maiden creek, Berks County, Pennsylvania, resolve as follows:

Section 1 - Declaration of Emergency

The Chairman of the Board of Supervisors of the Township of Maiden creek declares that the flooding experienced by the Township on July 9, 2023, constitutes an emergency and an immediate threat to the public health, welfare, and safety which could lead to serious injury, such that the necessary repairs cannot be delayed.

Section 2 - Authorizations

Due to the Emergency, the Chairman of the Board of Supervisors of the Township of Maiden creek authorizes the Township Manager, consultants, and staff to make repairs, purchase supplies, and assess the damage caused by the floods without the need to go through the normal bidding process. The Township Manager, consultants, and staff, shall, if practical, use the state bid and quote requirements but expedite the necessary emergency repairs, without delay.


Section 3 - Requests Assistance from Other Public Agencies

The Chairman of the Board of Supervisors requests the intervention of other adjoining overlapping public agencies and specifically requests the appropriate assistance of county,


state, and federal emergency management agencies in response to the damage caused by the floods.




