# MAIDENCREEK TOWNSHIP BERKS COUNTY, PENNSYLVANIA RESOLUTION NO. 05 – 2023

A RESOLUTION APPOINTING A CONSULTANT AS THE ZONING OFFICER, CODE ENFORCEMENT OFFICER AND BUILDING CODE OFFICIAL

WHEREAS the Board of Supervisors of Maidencreek Township desire to appoint a consultant to act as a Zoning and Code Enforcement Officer, in accordance with section 614 of the Pennsylvania Municipalities Planning Code to administer the Maidencreek Township Zoning Ordinance of 1993 and any other ordinance adopted by Maidencreek Township;

WHEREAS the Board of Supervisors of Maidencreek Township desire to appoint a consultant to act as the Building Code Official, in accordance with Pennsylvania Construction Code Act and Regulations, to administer and enforce the Uniform Construction Code;

**NOW, THEREFORE** in consideration of the above recitals, the Board of Supervisors of the Township of Maidencreek, Berks County, Pennsylvania, resolves as follows:

### Section 1 - Appointment of Zoning and Code Enforcement Officer

The Board of Supervisors of Maidencreek Township hereby appoints Systems Design Engineering whose principal office is located at 1032 James Drive, Leesport, PA 19533 as the Township Zoning and Code Enforcement Officer. They shall serve in accordance with Section 614 of the Pennsylvania Municipalities Planning Code.

### Section 2 - Appointment of the Building Code Official

The Board of Supervisors of Maidencreek Township hereby appoints Great Valley Consultants as Township Building Code Official whose principal office is located at 1032 James Drive, Leesport, PA 19533 as the Township Building Code Official. They shall serve in accordance with Pennsylvania Construction Code Act and Regulations.

#### **Section 3 - Term of Office**

The term of this appointment shall be from this third day of January 2023 AD until the next Maidencreek Township Reorganization Meeting to be held the second day of January 2024 AD. The Zoning and Code Enforcement Officer and Building Code Official serves at the pleasure of the Board of Supervisors.

#### Section 4 - Fee Schedule

The fees for the activities of the Zoning and Code Enforcement Officer and the Building Code Official shall be in accordance with the comprehensive fee schedule resolution.
